RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE DEL R. DE GUZMAN, TO ENTER INTO AND SIGN AN INTERNET SERVICE AGREEMENT WITH PHILIPPINE TELEGRAPH AND TELEPHONE INC. (PT&T), RELATIVE TO THE PROVISION OF VARIOUS INTERNET REQUIREMENTS OF THE CITY

WHEREAS, on March 19, 2014, the City Council of Marikina approved Resolution No. 044, Series of 2014 which authorized the City Mayor, on behalf of the City Government of Marikina, to enter into a Service Agreement with Black Fiber Solutions Corporation relative to the provision of various internet requirements of the City;

WHEREAS, the aforementioned Agreement will expire on May 21 of the current year and as such, there is a need to once again secure the services of an internet service provider (ISP) for the purpose;

WHEREAS, the Management Information System and Call Center (MISCC) Office of the City have discussed with different ISPs to be able to find a company that would provide the best services at the lowest rate;

WHEREAS, the Philippine Telegraph and Telephone Inc. has offered a higher bandwidth of 12Mbps at the same rate of Fifty Thousand Pesos (₱50,000.00) per month as against the existing 8Mbps being served to the City by the current provider, Black Fiber Solutions;

WHEREAS, the terms and conditions which the parties will agree upon shall be embodied in an Internet Service Agreement (as per attached draft);

WHEREAS, pursuant to Section 455 (b), sub-paragraph (1) of the Local Government Code of 1991, the City Mayor, as chief executive of the city government shall exercise general supervision and control over all programs, projects, services, and activities of the city government, x x x and shall:

“(vi) Represent the City in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the sangguniang panlungsod or pursuant to law or ordinance x x x”


NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED by the SANGGUNIANG PANLUNGSOD of MARIKINA, in session duly assembled, to authorize the City Mayor, Honorable Del R. De Guzman, on behalf of the City Government of Marikina, to enter into and sign an Internet Service Agreement with Philippine Telegraph and Telephone, Inc. for the provision of various internet requirements of the City.

RESOLVED FURTHER, that a copy of this Resolution be furnished to the City Mayor, Honorable Del R. De Guzman, and other concerned offices for their information and appropriate action.


