RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR DEL R. DE GUZMAN TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT BETWEEN THE CITY GOVERNMENT OF MARIKINA, AND THE INFORMATION AND COMMUNICATIONS TECHNOLOGY OFFICE, HEREIN REPRESENTED BY ITS EXECUTIVE DIRECTOR, LOUIS NAPOLEON C. CASAMBRE FOR THE ESTABLISHMENT OF FREE WIFI INTERNET ACCESS SERVICE

WHEREAS, the national government through the Department of Science and Technology Office (DOST)-Information and Communication Technology Office (ICT Office) is undertaking the Free WiFi Internet Access in Public Places Project across the Philippines to accelerate economic, social and educational opportunities and in reducing the growing Digital Divide under the overarching e-Filipino Program of the Government;

WHEREAS, the Project is envisioned to provide Free WiFi Internet Access in public places nationwide, but will initially cover Class 3, 4, 5, 6 municipalities, selected major cities and public places such as Public Schools, Libraries, Hospitals, Rural Health Units, Police Stations, State Universities and Colleges, Public Transport Terminals, Seaports, and Airports;

WHEREAS, the Department of the Interior and Local Government (DILG), together with the League of Municipalities of the Philippines (LMP) and Department of Science and Technology (DOST), have agreed to cooperate and jointly commit in promoting community development through the use of information and communications technology for effective and efficient national and local governance in the country. Towards this end, the Memorandum of Understanding (MOU) dated July 24, 2015 was entered into by the Parties;

WHEREAS, it is the policy of the City Government of Marikina to fully support, cooperate and commit itself to the implementation and success of national programs in as much as the same are intended to achieve development goals that will eventually benefit the people in particular;

WHEREAS, the City Government of Marikina subscribes to the Free WiFi Internet Access in Public Places Project, and as such it is imperative to establish a working and institutional relationship with the Department of Science and Technology (DOST)-Information and Communications Technology Office (ICT Office) to insure the implementation and success of the Project in the locality, by entering into the Memorandum of Agreement presented to this Sanggunian;

WHEREAS, pursuant to Section 455 (b), sub-paragraph (1) of the Local Government Code of 1991, the City Mayor, as chief executive of the city government shall exercise general provision and control over all programs, projects, services and activities of the city government, xxx and shall:

“(vi) Represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligations, and such other

documents upon authority of the SangguniangPanlungsod or pursuant to law or ordinance x xx”

NOWTHEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED by the **SANGGUNIANG PANLUNGSOD of MARIKINA**, in session duly assembled, to authorize the City Mayor Honorable Del R. De Guzman, on behalf of the City Government of Marikina, to enter and sign a Memorandum of Agreement between the City Government of Marikina, and the Information and Communications Technology Office, herein represented by its Executive Director Louis Napoleon C. Casambre for the establishment of Free WIFI Internet Access Service ;




