WHEREAS, Section 15 Article II of the 1987 Constitution states that:

“The State shall protect and promote the right to health of the people and instill health consciousness among them.”

WHEREAS, RA 7160 otherwise known as the Local Government Code of 1991 mandates the Local Government Units to promote the general welfare of their constituency and enact ordinances which will promote the general welfare and health of their constituents within their respective territorial jurisdictions;

WHEREAS, Paragraph (5) Subparagraph (xiv) of Section 458 of RA 7160 otherwise known as the Local Government Code of the Philippines states that:

*“SECTION 458. Powers, Duties, Functions and Compensation.-
(a)The Sangguniang Panlungsod, as the legislative body of the city, shall enact ordinances approve resolutions and appropriate funds for the general welfare of the city inhabitants x x x*

(5) Approve ordinances which shall ensure the effective delivery of the basic services and facilities as provided for under Section 17 of this code, and in addition to said services and facilities, shall:

x x x

(xiv) Provide for the care of disabled persons, paupers, the aged, the sick, persons of unsound mind, abandoned minors, juvenile delinquents, drug dependents, abused children and other needy disadvantaged persons, particularly children and youth below eighteen (18) years of age; x x x.

WHEREAS, it is incumbent upon the City Government of Marikina to formulate policies and adopts certain measure that will help the residents of Marikina to free access on medical services and facilities;

WHEREAS, it will be a great help to the residents of the City especially to the indigents if they will be provided free hospitalization, thus making them feel that they are not being left behind by the City Government.



UNANIMOUSLY ADOPTED BY THE SANGGUNIANG PANLUNGSOD OF MARIKINA this 22nd day of June 2016.


