WHEREAS, on May 27, 2016, Chemical Alloy Corporation sent a letter of appeal to the City Council requesting for reconsideration for the approval of their location clearance being denied by the City Planning and Development Office;

WHEREAS, the request for reconsideration is for the proposed warehouse as storage for motor oil in steel drum containers, motor oil in plastic pail containers, cases of motor oil in plastic bottle containers and empty plastic bottle containers;

WHEREAS, series of committee hearings and a site inspection were conducted to determine if the request is meritorious;

WHEREAS, during the committee hearing, Chemical Alloy Corporation presented an approved location clearance being issued by the City Planning and Development Office dated October 11, 2012 in which states that tolling and filling of lubricant services is allowed under C-2 or Medium Density Commercial Zone;

NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED BY THE CITY COUNCIL OF MARIKINA, in session duly assembled, to grant on the continued storage of chemicals, petroleum, oil, plastics and other products of Chemical Alloy Corporation operating in a non-industrial zone located at #227 Gen. Ordoñez St. corner Balagtas St. Brgy. Parang, this City .


