WHEREAS, among the considered historic legislative milestones which he principally authored are the following: Ordinance No. 15 Series of 2016 entitled an "Ordinance Institutionalizing, Promoting And Developing Urban Gardening In Marikina City And Providing Funds Therefor"; Ordinance No. 47 Series of 2015 entitled an "Ordinance Declaring The Last Monday Of March Every Year As Fire Service Recognition Day In Marikina City;" Ordinance No. 69 Series of 2015 otherwise known as "An Ordinance Extending Financial Assistance For Death Expenses Of Persons With Disabilities Of Marikina City"; Resolution No. 126, Series of 2015 entitled "Resolution Encouraging All Marikeños And All Local And National Government Offices, Educational Institutions At All Levels, Non- Government Organizations, Homeowners Associations, Cooperatives And Other Civic Groups Within Marikina City To Include The Singing Of The Marikina Hymn As Part Of The Programs Or Activities During The Conduct Of Their Official Or Formal Meetings, Sessions, Affairs, Activities Whether Public Or Private Gatherings Or Assemblies And During Their Flag Raising Or Retreat Ceremonies Among Others"; Ordinance No. 044 Series of 2015 known as an "Ordinance Amending Ordinance No. 35 Series of 1992 Otherwise Known As An Ordinance Adopting The New Seal Official Seal Of The Sangguniang Bayan of Marikina And Providing Penalties For The Illegal Use Thereof"; and Ordinance No. 069 Series of 2015 otherwise known as an "Ordinance Extending Financial Assistance For Death Expenses Of Persons With Disabilities In Marikina City";

WHEREAS, his meritorious service of three years as a member of the 7th City Council has proven him worthy of recognition by his peers and the people of Marikina City especially during natural and man-made disasters when he heroically performed, as he continues to do so, his task in helping save lives and properties of the Marikeños;






