WHEREAS, Section 108 of R.A No.7160 otherwise known as a Local Government Code of 1991 provides:

*“Section 108. Representation of Non-governmental Organizations. x x x
The local sanggunian concerned shall accredit nongovernmental
organizations subject to such criteria as may be provide by law. x x x”*

WHEREAS, Article 62 of Rules and Regulations Implementing the Local Government Code of 1991 provides;

*“x x x LGUs shall promote the establishment and operation of people’s
organizations, NGOs, and the private sector , to make them active partners
in the pursuit of local autonomy. x x x”*

WHEREAS, Article 64 of the same Rules and Regulations further provides:

*“x x x each sanggunian concerned shall call all community-based
people’s organizations or NGOs including business and professional
groups, and other similar aggrupations to apply with the LGU concerned
for accreditation x x x”*

WHEREAS, the City Council of Marikina passed Ordinance No.14, Series of 1997 on January 22, 1997 which requires all Non-Government Organizations (NGOs), and socio-civic community and homeowners associations in Marikina to register with the city government in accordance with the requirements provided in the said ordinance;

WHEREAS, the **“PAMANTASAN NG LUNGSOD NG MARIKINA FACULTY ASSOCIATION”** has expressed its intention and willingness to be accredited by the City Government of Marikina, in order to be legally recognized and lawfully conduct its activities for the community and has conformed to the documentary requirements prescribed therefor;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED by the **SANGGUNIANG PANLUNGSOD OF MARIKINA**, in session duly assembled to accredit the **“PAMANTASAN NG LUNGSOD NG MARIKINA FACULTY ASSOCIATION”** of Marikina City pursuant to Section 108 R.A. No 7160, otherwise known as the Local Government Code of 1991, Articles 62 and 64 of the Rules and Regulations implementing the same Act and Ordinance No.14, Series of 1997.

RESOLVED FURTHER, that copies of this resolution be furnished to all concerned offices of the City Government and the officers of the concerned association for their information.


