WHEREAS, the City Government of Marikina is the owner of one (1) Plastic Boat fitted with one (1) Yamaha Outboard Motor, six (6) oars/paddles, six (6) life vests, six (6) helmets and one (1) bolt cutter;

WHEREAS, the aforementioned equipment will be donated to the Samahang Magdalo Group Marikina Chapter, a non-government organization duly registered with the Securities and Exchange Commission and is represented herein by its President, Mr. Dennis Alexander B. Viloso;

WHEREAS, the Samahang Magdalo Group Marikina Chapter will utilize the aforementioned equipment to assist the City Government in its disaster mitigation programs in the City;

WHEREAS, Section 455 of the Local Government Code of 1991 provides that:

“(b) For efficient, effective and economical governance the purpose of which is the general welfare of the city and its inhabitants pursuant to Section 16 of this Code, the City Mayor shall:

(vi) Represent the City in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance; x x x”

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED by the SANGGUNIANG PANLUNGSOD of MARIKINA, in session duly assembled, to authorize the City Mayor, Honorable Del R. De Guzman to enter into and sign the Deed of Donation between the City Government of Marikina and Samahang Magdalo Group Marikina Chapter relative to the donation of one (1) Plastic Boat fitted with one (1) Yamaha Outboard Motor, six (6) oars/paddles, six (6) life vests, six (6) helmets and one (1) bolt cutter.

RESOLVED FURTHER, that a copy of this Resolution be furnished the Samahang Magdalo Group Marikina Chapter, through its President, Mr. Dennis Alexander B. Viloso and other concerned offices for their information and appropriate action.
