RESOLUTION AUTHORIZING THE DEDUCTION OF THE EXPENSES TO BE INCURRED BY THE PHILIPPINE NATIONAL BANK FOR THE REPAIR OF THE ROOF OF THE BUILDING FROM ITS MONTHLY RENTAL TO THE CITY GOVERNMENT THEREBY AUTHORIZING THE CITY MAYOR, HONORABLE DEL R. DE GUZMAN, TO ENTER INTO AND SIGN A SUPPLEMENTAL AGREEMENT BETWEEN THE CITY GOVERNMENT OF MARIKINA AND THE PHILIPPINE NATIONAL BANK-MARIKINA BRANCH

WHEREAS, on July 22, 2015 the Sangguniang Panlungsod of Marikina unanimously adopted Resolution No. 115, Series of 2015 which authorized the City Mayor, Honorable Del R. De Guzman to enter into and sign a Contract of Lease between the City Government of Marikina and the Philippine National Bank relative to the lease of the City Government owned property located at the corner of Shoe Avenue and W. Paz Streets, Barangay Sta. Elena, Marikina City;

WHEREAS, the said lease Agreement between the City Government of Marikina and the Philippine National Bank is for a term of five (5) years and for a monthly rental of Two Hundred Five Thousand Eight Hundred Thirty Eight Pesos and Twenty Nine Centavos (₱205,838.29);

WHEREAS, however, the Philippine National Bank, through its Vice President and Head Branch and ATM Development Division, has expressed the necessity to renovate the building that they are currently leasing from the City Government of Marikina, specifically its roofing;

WHEREAS, since the City Government of Marikina cannot release funds for said renovation in light of the election ban, the Philippine National Bank has proposed that they will be shouldering the cost of the roof replacement works in the amount of Seven Hundred Forty Five Thousand Pesos (₱745,000.00) and offset the same against its monthly rental payments;

WHEREAS, pursuant to Section 455 (b), sub-paragraph (1) of the Local Government Code of 1991, the City Mayor, as chief executive of the city government shall exercise general supervision and control over all programs, projects, services, and activities of the city government, x x x and shall:

“(vi) Represent the City in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the sangguniang panlungsod or pursuant to law or ordinance x x x”

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED by the SANGGUNIANG PANLUNGSOD of MARIKINA, in session duly assembled, to authorize the deduction of the expenses to be incurred by the Philippine National Bank for the repair of the roof of the building from its monthly rental to the City Government of Marikina thereby authorizing the City Mayor, Honorable Del R. De Guzman, on behalf of the City Government of Marikina, to enter into and sign a Supplemental Agreement with Philippine National Bank-Marikina Branch herein represented by Mr.

Dwight Lawrence T. Leyco, Vice President/Head-Branch Expansion and Development Department.

RESOLVED FURTHER, that a copy of this Resolution be furnished to the City Mayor, Honorable Del R. De Guzman, the Philippine National Bank and all concerned offices/agencies, for their information.
