Ancajas and T/A I Aaron Martin C. Castillo were patrolling along the jogging lane at the Marikina River Park when they spotted one (1) male urinating in public;

WHEREAS, said person was apprehended for clear violation of Ordinance No. 43, Series of 1999 or the "Ordinance Prohibiting Urinating and Defecating in All Public Places within the City of Marikina and Imposing Penalties for Violation Therefor";

WHEREAS, upon verification of the suspect, he was instructed by the apprehending officers to show the content of his pocket wherein they recovered suspected dried marijuana leaves on the left and right front pockets of his short pants;

WHEREAS, suspect was then apprised of his constitutional rights and the inventory of the recovered evidence was witnessed by Barangay Kagawad Sandoval Suarez;

WHEREAS, the suspect and the recovered evidence were brought to the Eastern Police District Crime Laboratory for examination and a case for violation of Article II, Section 11 of Republic Act No. 9165 or the Comprehensive Dangerous Drugs Act of 2002;

WHEREAS, the operatives of the Office of Public Safety and Security have shown their exemplary performance in the conduct of their duties;



RESOLVED FURTHER, that copies of this Resolution be given to the aforementioned operatives for their information.


