TEODORO TO TRANSACT BUSINESS WITH INTERESTED AND QUALIFIED LESSEES FOR THE PURPOSE

WHEREAS, Christmas, aside from being a religious activity wherein we celebrate the birth of our Creator, has always been recognized as the season for merry-making especially for children;

WHEREAS, it has been an annual practice of the City Government of Marikina to conduct its annual Christmas Festival from the month of October until the first week of January of the succeeding year;

WHEREAS, one of the activities for the Christmas Festival is the conduct of a Bazaar or *Tiangge*, along the Marikina River Park;

WHEREAS, on August 27, 2014, the City Council enacted Ordinance No. 055, Series of 2014 entitled, "Ordinance Regulating Bazaars (Tiangge) and Other Related Activities in the City of Marikina";

WHEREAS, Section 5 of the aforementioned City Ordinance states that:

"SECTION 5. CITY COUNCIL APPROVAL. Bazaar, Tiangge and other related activities conducted on any public places shall require a prior City Council Ordinance or Resolution as the case may be approving or allowing temporary closure of the public place/s that will be affected by the operation of the bazaar and/or other related activities."

WHEREAS, in preparation for the conduct of a Bazaar, the Committee on Awards of the City Government of Marikina will be conducting a public bidding for the lease of government spaces or stalls of the bazaar;


NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED by the **SANGGUNIANG PANLUNGSOD OF MARIKINA**, in session duly assembled to allow the temporary closure of a portion of the Marikina River Park for the conduct of a Bazaar or "Tiangge" and other related activities therein from October 2016 to January 2017.

RESOLVED FURTHER, to authorize the City Mayor, Honorable Marcelino R. Teodoro, to transact with interested and qualified lessees for the purpose;

RESOLVED FINALLY, that a copy of this resolution be furnished the City Mayor, Honorable Marcelino R. Teodoro, and other concerned offices/agencies for their information and appropriate action.
