RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE MARCELINO R. TEODORO, ON BEHALF OF THE CITY GOVERNMENT OF MARIKINA, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT WITH THE NATIONAL FOOD AUTHORITY TO IMMEDIATELY AVAIL OF NFA RICE ON CREDIT FOR RELIEF OPERATIONS DURING EMERGENCIES

WHEREAS, Local Government Units (LGUs) are mandated to provide basic social services to their constituents at all times but most especially in times of calamities and other emergencies;

WHEREAS, Local Government Units are authorized to set aside from their Estimated Revenue from Regular Sources five percent (5%) for Calamity Fund and twenty percent (20%) for Special Development Fund inclusive of their Internal Revenue Allotment (IRA);

WHEREAS, the National Food Authority (NFA) is mandated to provide assistance by granting rice loan to LGUs as a relief and response to the need of the people during emergency situations;

WHEREAS, based on the above premise, the rice loan to LGUs was conceptualized in order to cushion the impact of any form of emergency or calamity to its constituents;


WHEREAS, the City Government of Marikina will be availing of 550 to 750 sacks of rice every quarter based depending the need of its constituents;

WHEREAS, Section 455 (b) (1) of the Local Government Code of 1991 provides that the City Mayor shall exercise general supervision and control over all programs, projects, services, and activities of the City Government, and shall:

“x x x (vi) Represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance; x x x”

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, by the **SANGGUNIANG PANLUNGSOD of MARIKINA**, in session duly assembled, to authorize the City Mayor, Honorable Marcelino R. Teodoro, on behalf of the City Government of Marikina, to enter into and sign a Memorandum of Agreement with the National Food Authority to immediately avail of NFA Rice on credit for relief operations during emergencies.


