TEODORO, FOR AND ON BEHALF OF THE CITY GOVERNMENT OF MARIKINA, TO ENTER INTO AND SIGN THE DEED OF DONATION OF FIREARMS FROM THE ARMS CORPORATION OF THE PHILIPPINES (ARMSCOR) FOR THE USE OF THE UNIFORMED PERSONNEL OF THE MARIKINA CITY POLICE STATION

WHEREAS, the Arms Corporation of the Philippines (ARMSCOR) is a firearms manufacturing company located in Barangay Fortune, Marikina City;

WHEREAS, ARMSCOR intends to donate to the City Government of Marikina sixty (60) units of 9mm. pistols as its support in the City's campaign against unlawful elements;

WHEREAS, the aforementioned firearms will be utilized by the Marikina City Police Station's uniformed personnel in the performance of their law enforcement functions towards peace and order, especially in the fight against criminality;

WHEREAS, Section 455 of the Local Government Code of 1991 provides that:

“(b) For efficient, effective and economical governance the purpose of which is the general welfare of the city and its inhabitants pursuant to Section 16 of this Code, the City Mayor shall:

(vi) Represent the City in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance; x x x”

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED by the SANGGUNIANG PANLUNGSOD of MARIKINA, in session duly assembled, to authorize the City Mayor, Honorable Marcelino R. Teodoro, on behalf of the City Government of Marikina, to enter into and sign the Deed of Donation between the City Government of Marikina and Arms Corporation of the Philippines relative to the donation of sixty (60) units 9mm. pistols.

RESOLVED FURTHER, that a copy of this Resolution be furnished the Office of the City Mayor, the Marikina City Police Station and other concerned offices for their information and appropriate action.


