WHEREAS, the Bottom-up Budgeting and Planning (BUB) aims to make the planning and budgeting processes of both local and national government more participatory, by involving grassroots communities in the delivery of national services to poor communities as part of the poverty reduction effort of National Government Agencies and Local Government Units (LGUs);

WHEREAS, the Department of Social Welfare and Development (DSWD) assisted the Human Resource Development and Poverty Reduction Cluster in the implementation of the pilot phase by facilitating the conduct of BUB Planning Activities, review and assessment of projects and approval of disbursement of funds to the eligible LGUs;

WHEREAS, the City Government of Marikina has been chosen as one of the beneficiaries of the program and as such it will be entering into a Memorandum of Agreement with the DSWD;

WHEREAS, pursuant to Section 455 (b), sub-paragraph (1) of the Local Government Code of 1991, the City Mayor, as chief executive of the city government shall exercise general supervision and control over all programs, projects, services, and activities of the city government, x x x and shall:

“(vi) Represent the City in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the sangguniang panlungsod or pursuant to law or ordinance x x x”

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED by the SANGGUNIANG PANLUNGSOD of MARIKINA, in session duly assembled, to authorize the City Mayor, Honorable Marcelino R. Teodoro, to enter into and sign a Memorandum of Agreement with Department of Social Welfare and Development for the implementation of Bottom-up Budgeting Projects, for and on behalf of the City Government of Marikina.


