WHEREAS, the Social Pension Program is project of the National Government being implemented through the Local Government Units which entitles indigent senior citizens to a monthly stipend of Five Hundred Pesos (₱500.00) to augment the daily subsistence and other medical needs of senior citizens;

WHEREAS, the grant of social pension is subject to eligibility criteria as determined by the Department of Social Welfare and Development (DSWD);

WHEREAS, in Marikina City, there are about 1,200 indigent senior citizens benefiting the program which is a big aide to them and their families;

WHEREAS, pursuant to Section 455 (b), sub-paragraph (1) of the Local Government Code of 1991, the City Mayor, as chief executive of the city government shall exercise general supervision and control over all programs, projects, services, and activities of the city government, x x x and shall:

“(vi) Represent the City in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the sangguniang panlungsod or pursuant to law or ordinance x x x”

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED by the **SANGGUNIANG PANLUNGSOD of MARIKINA**, in session duly assembled, to authorize the City Mayor, Honorable Marcelino R. Teodoro, to enter into and sign a Memorandum of Agreement with Department of Social Welfare and Development for the implementation of the Social Pension Program, for and on behalf of the City Government of Marikina.

RESOLVED FURTHER, that a copy of this Resolution be furnished to the City Mayor, Honorable Marcelino R. Teodoro and all concerned offices/agencies, for their information.


