WHEREAS, the Sustainable Livelihood Program of the Department of Social Welfare and Development is a community-based capacity building program which equips participants to actively contribute to production and labor markets by looking at available resources and accessible markets;

WHEREAS, it also improves the socio-economic status of poor individuals by creating more employment and entrepreneurial opportunities;

WHEREAS, the City Government of Marikina, through its Social Welfare and Development Office, has chosen beneficiaries who will be given food carts containing goods amounting to Ten Thousand Pesos (₱10,000.00) which will enable them to start their own business;

WHEREAS, for the aforementioned purpose, the City Government of Marikina will be entering into a Memorandum of Agreement with the DSWD;

WHEREAS, pursuant to Section 455 (b), sub-paragraph (1) of the Local Government Code of 1991, the City Mayor, as chief executive of the city government shall exercise general supervision and control over all programs, projects, services, and activities of the city government, x x x and shall:

"(vi) Represent the City in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the sangguniang panlungsod or pursuant to law or ordinance $x \, x \, x$ "

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED by the SANGGUNIANG PANLUNGSOD of MARIKINA, in session duly assembled, to authorize the City Mayor, Honorable Marcelino R. Teodoro, to enter into and sign a Memorandum of Agreement with Department of Social Welfare and Development for the implementation of the Sustainable Livelihood Program, for and on behalf of the City Government of Marikina.

RESOLVED FURTHER, that a copy of this Resolution be furnished to the City Mayor, Honorable Marcelino R. Teodoro and all concerned offices/agencies, for their information.
