**WHEREAS**, on September 7, 1988, the then Municipal Council of Marikina enacted Ordinance No. 45, Series of 1988, as amended, declaring all areas as Emergency Relocation Centers (ERCS) shall be converted in a Permanent Settlement Site, and all settlers and relocates thereon shall be given the opportunity to buy lots they occupy at affordable rates under the Socialized Housing Program of the government;

**WHEREAS**, parcels of land situated at ERC Champaca II Park Lot 10-27, Brgy. Fortune, this City, was declared as permanent Settlement Site;

**WHEREAS**, the sale of individual lots to occupant-awardees and/or beneficiaries of government-owned properties must be covered by a Deed of Absolute Sale or Contract of Sale to be executed by and between the Local Chief Executive and the concerned awardees/beneficiaries;

**WHEREAS**, Section 455 (b) (1) (iv) of the Local Government Code of 1991 provides that the city mayor, as chief executive of the government shall *“Represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance”*;

**NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the **SANGGUNIANG PANLUNGSOD** to authorize the City Mayor, Honorable Marcelino R. Teodoro, for and in behalf of the City Government of Marikina, to enter into a Deed of Absolute Sale or Contract of Sale relative to the transfer of ownership of individual lots situated at EC Champaca II Park Lot 10-27, Brgy. Fortune, this City, in favor of the awardees/beneficiaries thereof;

**RESOLVED FURTHER** to let copies of this Resolution be furnished the City Mayor, Honorable Marcelino R. Teodoro, Mr. Arvin Santos, Head of Marikina Settlements Office and Ms. Nena Tiglao, LMG-Coordinator for their information and appropriate action.


