**WHEREAS**, Section 455 of Republic Act No. 7160 otherwise known as the Local Government Code of 1991 provides that local chief executives shall represent City in all business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance;


**NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the **SANGGUNIANG PANLUNGSOD** to authorize as it hereby authorizes the Honorable City Mayor Marcelino R. Teodoro to enter into a Memorandum of Agreement with Marikina Valley Ministerial Fellowship (MARVAL) Incorporated for the use of the vacant room located at the 3<sup>rd</sup> Floor of the Dry Goods Building, Marikina Public Market, Barangay Sta. Elena, Marikina City for their office use;


