WHEREAS, Section 23, Article II of the 1987 Constitution provides that:

“The State shall encourage non-governmental, community-based, or sectoral organizations that promote the welfare of the nation.”

WHEREAS, Section 108 of R.A. 7610 otherwise known as the Local Government Code of 1991 provides:

*“Section 108. Representation of Non-governmental Organizations. x x x
The local Sanggunian concerned shall accredit non-governmental organizations subject to such criteria as may be provided by law. x x x”*

WHEREAS, Article 62 of the Rules and Regulation Implementing the Local Government Code of 1991 provides:

“x x x Local Government Units shall promote the establishment and operation of people’s organizations, NGOs and the private sector to make them active partners in the pursuit of local autonomy. x x x”

WHEREAS, Article 64 of the same Rules and Regulation further provides:

“x x x each Sanggunian concerned shall call all community-based people’s organization of NGOs, including business and professional groups, and other similar aggrupations to apply with the Local Government concerned for accreditation x x x.”

WHEREAS, the *Sangguniang Panlungsod* of Marikina encourages all non-government organizations, socio-civic community and homeowners association in Marikina to register with the City Government in accordance with the requirements provided by Ordinance No. 14, Series of 1997;

WHEREAS, the Marikina City Junior Police Alumni Association Inc., has complied with all the documentary requirements set forth by law. Their programs and projects prove to have significant impact in this City; hence, it is only proper for the *Sanggunian* to recognize them as non-government organization.

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED BY THE SANGGUNIANG PANLUNGSOD OF MARIKINA, in session duly assembled to accredit the Marikina City Junior Police Alumni Association Inc., as non-government organization.

RESOLVE FURTHER, to furnish Marikina City Junior Police Alumni Association Inc., a copy of this Resolution for their information.




