TEODORO, REPRESENTING THE CITY GOVERNMENT OF MARIKINA TO APPROVE, SIGN LEGALLY BINDING AGREEMENTS NEEDED FOR THE EFFECTIVE IMPLEMENTATION OF THE PROGRAMS/PROJECTS/ACTIVITIES (PPAs) UNDER GENDER AND DEVELOPMENT (GAD) AND MANPOWER DEVELOPMENT AND TRAINING OFFICE (MDTO).**

**WHEREAS**, the functions of the Manpower Development and Training Office (MDTO) are to: (1) formulate and manage training and development for the purpose of job enrichment and job engineering of LGU personnel towards the goal of organizational excellence;(2) increase the citizenry's level of community consciousness and participation;(3) orient and/or train visitors from government entities, NGOs and academe; and (4) develop measures and mechanisms toward the objective of assessing micro and macro training and development needs, creating feedback systems and setting policies for contingency management and organizational and community development;

**WHEREAS**, Executive Order No. 006, Series of 2011 mandated the MDTO to act as the Gender and Development (GAD) secretariat, and as such, it performs functions of the GAD Office (GADO) stated in the Marikina GAD Code 2015 Article III, Section 2;

**WHEREAS**, MDTO needs to create partnerships with professional individuals, groups and institutions that are skilled and qualified to provide services required to effectively implement the foregoing services and PPAs;

**WHEREAS**, to materialize these undertakings, the City Mayor must be legislatively recognized as the City's representative in legally binding agreements and must be given full authority to approve and sign the following:

1. Contracts of services for:
  - a. resource persons needed in MDTO core curricular programs on various areas of development such as personhood, organizational development, governance and community making;
  - b. livelihood skills training instructors;
  - c. soft skills training resource persons;
  - d. TESDA accredited assessment centers;
  - e. tutorial services for Women and Children's school-age residents;
  - f. program coordinators and social workers or community coordinators of Scholarship Assistance for Youth in Especially Difficult Circumstance (SYEDC);
  - g. resource persons for Gender-Integrated Entrepreneurship Program (GIEP);
  - h. hiring of legal consultants and legal aide;
  - i. hiring of technical consultants, program coordinators and organizers for the implementation of capacity development, advocacy and monitoring and evaluation projects and activities; and

- j. identified resource persons for all capacity building projects/activities for GAD management team, secretariat staff, referral system and other stakeholders; and
  - k. printing, publication and production of IEC materials for advocacy programs and activities.
2. Memorandum of Agreement with:
- a. Marikina Polytechnic College (MPC) on the conduct of technical-vocational courses;
  - b. Sentrong Alternatibong Lingap Panligal (SALIGAN) to further strengthen our legal services by partnering with a legal resource non-government organization;
  - c. Women's Legal Bureau for legal education on pro-women laws;
  - d. Gota de Leche Foundation for nutrition program; and
  - e. Other identified institutions/groups for strengthening the referral network.

**NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED** by the **CITY COUNCIL OF MARIKINA**, in session duly assembled, to authorize as it hereby authorizes the Honorable City Mayor Marcelino R. Teodoro, representing the City Government of Marikina to approve, sign legally binding agreements needed for the effective implementation of the programs/projects/activities (PPAs) under Gender and Development (GAD) and Manpower Development and Training Office (MDTO)
