**WHEREAS**, the Office for Social Concern and Involvement (OSCI) is the student social formation arm of the Ateneo de Manila University mandated to bring the university closer to the greater society by initiating and nurturing correspondence and partnership with various stakeholders from public and private sectors;

**WHEREAS**, the Ateneo de Manila University (ADMU) seeks to form its students for service through its Ateneo Development Field School (ADSF) Programs comprising the Introduction to Ateneo Culture and Traditions (InTACT), National Service Training Program Plus (NSTP-PLUS) and Junior Engagement Program (JEEP) through the joint effort of its Office for Social Concern and Involvement (OSCI);

**WHEREAS**, the City Government of Marikina, in coordination with the OSCI, will be facilitating the conduct of these ADMU's Outreach Programs by identifying areas where students' involvement can be accommodated;

**WHEREAS**, the terms and conditions which the parties will agree upon shall be embodied in the Memorandum of Agreement (as per attached draft);

**WHEREAS**, Section 455 of Republic Act No. 7160 otherwise known as the Local Government Code of 1991 provides that the local chief executive shall represent City in all business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance;

**NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the **SANGGUNIANG PANLUNGSOD of MARIKINA** to authorize the City Mayor, Honorable Marcelino R. Teodoro, to enter, for and in behalf of the City Government of Marikina, into a Memorandum of Agreement (MOA) with the Ateneo de Manila University (ADMU) Office for Social Concern and Involvement (OSCI) regarding the implementation of ADMU's Outreach Programs;

**RESOLVED FURTHER** to let copies of this Resolution be furnished the City Mayor, Honorable Marcelino R. Teodoro and all concerned offices, for their information and appropriate action.
