RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR MARCELINO R. TEODORO, REPRESENTING THE CITY GOVERNMENT OF MARIKINA, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT WITH THE NATIONAL HOUSING AUTHORITY (NHA) REGARDING THE "HOUSING MATERIALS ASSISTANCE PROJECT FOR FAMILIES AFFECTED BY TYPHOON/CALAMITIES IN THE CITY OF MARIKINA"

WHEREAS, the National Housing Authority (NHA), a national government agency, had chosen Marikina City as a recipient for their project dubbed as "Housing Materials Assistance Project for families affected by Typhoon/Calamities", pursuant to Executive Order No. 90, Series of 2014;

WHEREAS, Republic Act No. 7160 and Republic Act No. 7279, otherwise known as the Local Government Code of 1991 and Housing Act of 1992, respectively, mandated local government units to take principal roles in the provision of housing services to their constituents;

WHEREAS, pursuant to NHA Board Resolution No. 5432 dated February 24, 2012 and NHA Board Resolution No. 5505 dated September 26, 2013, has approved the re-establishment of the Housing Materials Assistance Program (HOMA) for calamity victims and approved its revised guidelines with NHA directly implementing projects under the program, respectively;

WHEREAS, the HOMA, which is intended to benefit low or marginal-income families whose house are partially or totally damaged by calamities such as typhoons, floods, earthquakes, volcanic eruption and other forms of catastrophe or disaster, involves the grant of housing materials to affected households for purposes of repair or reconstruction of housing units in their present location;

WHEREAS, on September 19, 2014 Typhoon Mario and heavy monsoon rains "Habagat" hit the country and caused devastation to thousands of families in Marikina City;

WHEREAS, based on the Damage Assessment Report prepared and certified by the City Social Welfare Development Office and endorsed to NHA, a total of 1,000 families in the City of Marikina City were affected;

WHEREAS, in the Project Proposal submitted by the NHA Pasig/Marikina/Manggahan District Office recommended to NHA management provision of HOMA assistance to a total of 1,000 families residing in Barangay Malanday, all within Marikina City whose houses were partially damaged by said calamity;

WHEREAS, Section 455 of Republic Act No. 7160 otherwise known as the Local Government Code of 1991 provides that local chief executives shall represent City in all business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance;

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED by the **SANGGUNIANG PANLUNGSOD of MARIKINA** in session duly assembled to authorize the Honorable City Mayor Marcelino R. Teodoro, representing the City Government of Marikina, to enter into and sign a Memorandum of Agreement with the National Housing Authority (NHA) regarding the "Housing Materials Assistance Project for Families Affected by Typhoon/Calamities in the City of Marikina".

RESOLVED FUTHER that copies of this Resolution be furnished the Honorable City Mayor Marcelino R. Teodoro, the Head of the City's Social Welfare Development Office and other concerned agencies and departments of the city government for their information, guidance and appropriate action.
