**WHEREAS**, Section 455 (b) sub-paragraphs 1 (vi) of Republic Act No. 7160 also known as the Local Government Code of 1991 states:


*" x x x the City Mayor shall represent the city in all its business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance x x x ;*

**NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, BY THE CITY COUNCIL OF MARIKINA**, in session duly assembled to authorize the Honorable City Mayor Marcelino R. Teodoro to represent the City Government of Marikina to act as originator of the Community Mortgage Program (CMP) for the loan application of Samahang Magkakapitbahay ng Purok III Homeowners Association, Inc. Phase II-B, Barangay Malanday, this City.


