WHEREAS, Republic Act No. 7279 otherwise known as the Urban Development and Housing Act of 1992 aims to provide affordable housing projects for the underprivileged and homeless;

WHEREAS, all local government units were tasked to implement the measure in their respective territories in coordination with the Presidential Commission on the Urban Poor (PCUP), Housing and Urban Development Coordinating Council (HUDCC), Housing and Land Use Regulatory Board, National Home Mortgage Program and other concerned agencies in support of the socialized housing programs under the act;

WHEREAS, Section 455 (b) sub-paragraphs 1 (vi) of Republic Act No. 7160 also known as the Local Government Code of 1991 states:


" x x x the City Mayor shall represent the city in all its business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance x x x ;

NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, BY THE CITY COUNCIL OF MARIKINA, in session duly assembled to authorize the Honorable City Mayor Marcelino R. Teodoro to represent the City Government of Marikina to act as originator of the Community Mortgage Program (CMP) for the loan application of Samahang Ilaw at Gabay Magkakapitbahay Homeowners Association, Inc. located at Purok 5, Barangay Malanday, this City.


RESOLVED FINALLY, that a copy of this resolution be furnished all concerned for their information and appropriate action.
