NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED by the **SANGGUNIANG PANLUNGSOD of MARIKINA**, in session duly assembled to declare Barangay Appropriation Ordinance No. 02, Series of 2016 of Barangay Tañong, this City, containing the Supplemental Budget No. 1 for C.Y. 2016 in the amount of Two Hundred Fifty Three Thousand Seven Hundred Fourteen Pesos and 32/100 (₱253,714.32), to be consistent with law.


