NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED by the **SANGGUNIANG PANLUNGSOD of MARIKINA**, in session duly assembled to declare Barangay Appropriation Ordinance No. 01, Series of 2016 of Barangay Sto. Niño, this City, containing the Supplemental Budget No. 1 for C.Y. 2016 in the amount of Two Million Two Hundred Forty Thousand Fifty Pesos and 23/100 (₱2,240,050.23), to be consistent with law.


