Teodoro to enter into and sign a memorandum of understanding between the City Government of Marikina and the Office of the Vice-President of the Philippines for the promotion of Anti-Poverty Frame Work.


**RESOLVED FINALLY**, that a copy of this resolution be furnished all concerned for their information and appropriate action.
