RESOLUTION AUTHORIZING HONORABLE CITY MAYOR MARCELINO R. TEODORO TO ENTER INTO AND SIGN CONTRACTS OF LEASE ON BEHALF OF THE CITY GOVERNMENT OF MARIKINA FOR THE LEASE OF STALLS AND SPACES AT THE MARIKINA PUBLIC MARKET, BARANGAY STA. ELENA, MARIKINA CITY

WHEREAS, the City Government of Marikina is the owner of a public market situated at W. Paz Street, Sta. Elena, this City;

WHEREAS, Section 8 of the Local Government Code of 1991 provides that:

“x x x Local government units shall have the power and authority to acquire, develop, lease, encumber, alienate, or otherwise dispose of real or personal property held by them in their proprietary capacity and to apply their resources and assets for productive, developmental, or welfare purpose”;

WHEREAS, Section 455 (b) (1) of the Local Government Code of 1991 provides that the City Mayor shall exercise general supervision and control over all programs, projects, services and activities of the City Government and shall:


“Represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the sangguniang panlungsod or pursuant to law or ordinance; x x x x

NOW, THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED BY THE SANGGUNIANG PANLUNGSOD OF MARIKINA, in session, duly assembled, to authorize the Honorable City Mayor Marcelino R. Teodoro to enter into and sign contracts of lease on behalf of the City Government of Marikina for the lease of stalls and spaces at the Marikina Public Market, Barangay Sta. Elena, Marikina City,

RESOLVED, FURTHER, that this authority shall cover lease contracts for renewal and new contracts
