WHEREAS, Section 455 of the Local Government Code of 1991 provides that:

“(b) For efficient, effective and economical governance the purpose of which is the general welfare of the city and its inhabitants pursuant to Section 16 of this Code, the City Mayor shall:

(vi) Represent the City in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance; x x x”

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED by the **SANGGUNIANG PANLUNGSOD of MARIKINA**, in session duly assembled, to authorize the City Mayor, Honorable Del R. De Guzman to enter into and sign the Deed of Donation between the City Government of Marikina and Nangka High School relative to the donation of one (1) Suzuki Utility Vehicle for the use of the school.


