WHEREAS, the Pantawid Pamilyang Pilipino Program (4Ps) is a human development measure of the national government that provides conditional cash grants to the poorest of the poor, to improve the health, nutrition, and the education of children aged 0-18;

WHEREAS, this program is currently being availed of by eight thousand four hundred (8,400) beneficiaries coming from the different Barangays of Marikina City;

WHEREAS, the beneficiaries are being given school, health and food grants to enable the children to go to school and live a healthy life which in turn will make these beneficiaries productive citizens in the future;


WHEREAS, for the aforementioned purpose, the City Government of Marikina will be entering into a Memorandum of Agreement with the DSWD;

WHEREAS, pursuant to Section 455 (b), sub-paragraph (1) of the Local Government Code of 1991, the City Mayor, as chief executive of the city government shall exercise general supervision and control over all programs, projects, services, and activities of the city government, x x x and shall:

“(vi) Represent the City in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the sangguniang panlungsod or pursuant to law or ordinance x x x”

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED by the **SANGGUNIANG PANLUNGSOD of MARIKINA**, in session duly assembled, to authorize the City Mayor, Honorable Marcelino R. Teodoro, to enter into and sign a Memorandum of Agreement with Department of Social Welfare and Development for the implementation of the Pantawid Pamilyang Pilipino Program, for and on behalf of the City Government of Marikina.


